

**Procedures:-**

1. **Current Committee to sign notice that they are available for re-election in their current Port Folio (Notice Board). New nominations can be made if acceptance has been signed by the nominated person for the Port Folio you nominate them for and seconded. Alternatively the existing Committee member can be re-instated on their acceptance on Notice Board.**
2. **New Nominations for vacant Port Folio's would work the same. Nominate / Signed acceptance by the nominated person and seconded.**
3. **If a Member is unable to attend and is in 'Good Standing' (Fully paid up at all levels) they are entitled to nominate a Proxy(Club Member in Good Standing) who in turn would attend and vote on their behalf for that specific request (listed). Forms will be available.**
4. **Topics for discussion to be put on the Agenda. It is imperative that this be listed with a short description. It will then be categorized and if completed – be listed as such. If it is new, it will be listed on the Agenda under it's category.**  
***Please note, if nothing is sent in and not listed on the Agenda – IT WILL NOT BE OPEN FOR DISCUSSION ON THE DAY OF THE AGM.***
